Course: 'Protection of human rights: beginning and end of life issues'

Course description

The course is addressed to doctoral students and first year undergraduate students, coming from any research area of the SSM. The final evaluation will take into account the students' different educational level.

The course aims to investigate critically the legal and private aspects of life sciences and human health care. Starting from the identification of the individual's fundamental rights in its physical and moral dimension will be analyzed the most current biolaw issues, especially when conditions of vulnerability are identified.

The traditional civil protection institutes will be addressed, recognizing and enhancing the space of decision-making autonomy of individuals and balancing the needs of health protection of the parties involved, even in situations of particular vulnerability, with the need to guarantee self-determination in existential choices.

The lessons, after a preliminary framing of the different cases that will gradually be examined, will focus on the analysis of practical cases, which will provide the starting point for critical reflection by students.

Aims

At the end of the course, students will be able to:

- know and understand the individual's personality rights from an evolutionary perspective.
- understand new biolaw issues linked with technological progress.
- provide coherent and justified solutions from a legal point of view.

Learning methods

- Classes will be based on discussions between the professor and students regarding the main issues arising from the background readings.
- All students are expected to actively participate in the debate, providing comments and raising questions on the issues discussed in class.

- Students will have to prepare a final presentation which has to examine in depth one of the aspects touched upon in the class. The work will be presented during the final class.

Course material

The course material will consist of legal and jurisprudential text, book chapters and journal articles. In addition to the required readings listed for each lecture, further readings will be suggested during the classes covering specific topics in greater detail.
