Social Rights in Europe

This workshop addresses topical issues of the regulation of social rights in Europe. It reflects on the historical evolution and present challenges of the legal architecture governing social security rights. It examines the network of interrelated regimes governing social rights in Europe including the European Convention of Human Rights, the EU, and the EEA. It discusses the interpretation of social security rights by European Courts. A second more operative part of the workshop tackles practical case studies relating to the reduction and withdrawal of social benefits, the possibility to 'export' those benefits in an EEA State different from the State granting them. The workshop aims at devising a framework for assessing commonalities and differences in the social security regulation in different national regimes in the context of European laws and practices.
